Bonds - Custodian Network

Funds - Network

Transfer Agent	Means the registrar and transfer agent of a Fund held by BdL acting on behalf of its customers, including the Fund in case the Fund does not delegate the registrar and transfer agent to a third party service provider.
Agent	Means an entity – that is appointed by the Fund or the Fund's management company or the Fund's AIFM; and – that is referred to in official publications of the Fund (such as the Fund's articles, management regulations, prospectus, private placement memorandum, notices to investors) or other publically available information as the Fund's agent for, among others, keeping in custody units of the Fund for the benefit of the Fund's investors.
Specialized Intermediaries	Means an entity that is neither a TA nor an Agent and that has been selected by BdL to keep in custody units of a Fund held by BdL acting on behalf of its customers.
